# COUNTY OF HAWAII - STATE OF HAWAII ORDINANCE NO. 556

AN ORDINANCE AMENDING SECTION 7.22 THE PAHOA ZONE MAP, ARTICLE 2, CHAPTER 8 (ZONING CODE) OF THE HAWAII COUNTY CODE, AS AMENDED, BY CHANGING THE DISTRICT CLASSIFICATION FROM SINGLE FAMILY RESIDENTIAL (RS-10) TO VILLAGE COMMERCIAL (CV-10) AT NANAWALE HOMESTEADS, PUNA, HAWAII, COVERED BY TAX MAP KEY 1-5-11:12.

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

SECTION 1. Section 7.22, Article 2, Chapter 8 (Zoning Code) of the Hawaii County Code, as amended, is hereby further amended by adding thereto the following subsection:

"7.22 (g). The district classification of the following area situated at Nanawale Homesteads, Puna, Hawaii, shall be Village Commercial (CV-10):

Beginning at a point at the Southwest corner of this lot and on the North side of Government Main Road, the coordinates of said point of beginning, referred to Government Survey Triangulation Station "VILLAGE FLAG," being 1,164.91 feet South and 1,581.06 feet East, thence running by azimuths measured clockwise from true South:

2. 304° 58' 55.10 feet along Lot 32 and Lot 33;

3. 28° 28' 30" 214.13 feet along Lot 10;

60.00 feet along the North side of Government Main Road to the point of beginning, containing an area of 12,456 square feet, more or less.

All as outlined in red on the map attached hereto, marked Exhibit 'A' and by reference made a part hereof.

This ordinance shall take effect forthwith upon the conditions that (A) the petitioner or his authorized representative submit plans for the conversion of the existing

building and any improvements including the provisions of the parking stalls, to be made to the Planning Department for Plan Approval. Further, Final Plan Approval shall be secured within one (1) year from the effective date of approval of the change of zone; (B) the proposed use shall be established within one (1) year from the date of receipt of Final Plan Approval; (C) all other applicable rules, regulations, and requirements, including those of the State Department of Health and the County Department of Public Works, shall be complied with. Should any of the foregoing conditions not be met, rezoning of the area to its original or more appropriate zoning designation may be initiated."

SECTION 2. In the event that any portion of this ordinance is declared invalid, such invalidity shall not affect the other parts of this ordinance.

SECTION 3. This ordinance shall take effect upon its approval.






