AN ORDINANCE AMENDING SECTION 7.03 (THE SOUTH KONA ZONE MAP), ARTICLE 2, CHAPTER 8 (ZONING CODE) OF THE HAWAII COUNTY CODE, AS AMENDED, BY CHANGING THE DISTRICT CLASSIFICATION FROM VILLAGE COMMERCIAL (CV-10) TO MULTIPLE FAMILY RESIDENTIAL (RM-1.5) AT KEEKEE 1ST, SOUTH KONA, HAWAII, COVERED BY TAX MAP KEY 8-1-12:9 AND 55.

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

The second

SECTION 1. Section 7.03, Article 2, Chapter 8, (Zoning Code), of the Hawaii County Code, as amended, is further amended to add a new subsection to read as follows:

"7.03 (bb). The district classification of the following area situated at Keeekee lst, South Kona, Hawaii, shall be Multiple Family Residential (RM-1.5):

Beginning at a spike at the northeast corner of this parcel of land, the coordinates of which referred to Government Survey Triangulation Station "PUU OHAU" being 1,579.60 feet North and 11,170.19 feet East and running by azimuths measured clockwise from true South:

1. 9° 56' 14.90 feet along the westerly side of Hawaii Belt Road to a pipe in concrete;

Thence along same on a curve to the left with a radius of 2322.01 feet, the azimuth and distance of the chord being:

2. 9° 22' 37" 45.10 feet to a pipe in concrete;

Thence continuing along same on the same curve to the left with the same radius of 2322.01 feet, the azimuth and distance of the chord being:

- 3. 7° 33' 20" 102.52 feet to a pipe in concrete (found);
- 4. 90° 04' 258.37 feet along Kona Public Library, Executive Order No. 1264, to a pipe in concrete (found);
- 5. 187° 08' 102.83 feet along Lot 16-A of Land Court Application 1609, to a pipe in concrete (found);

- 6. 270° 09' 30" 92.32 feet along Lots 15 and 1 of
 Land Court Application 1609 to
 a pipe in concrete;
- 7. 188° 56' 88.32 feet along Lot 1 of Land Court Application 1609 to a pipe in concrete;
- 8. 279° 56' 165.45 feet along Lots 3-B-1 and 3-A of Land Court Application 1609 to the point of beginning and containing an area of 0.885 Acres.

All as outlined in red on the map attached hereto, marked Exhibit "A" and by reference made a part hereof.

This subsection is conditioned upon the following:

- (A) that plans for the proposed service building and the additional parking area shall be submitted to the Planning Department and final plan approval secured within one (1) year from the effective date of the Change of Zone;
- (B) that construction of the improvements commence within one (1) year from the date of receipt of final plan approval and be completed within three (3) years thereafter; (C) that all other applicable rules, regulations, and requirements be complied with. Should any of the foregoing conditions not be met, rezoning of the area to its original or more appropriate zoning designation may be initiated. "

SECTION 2. In the event that any portion of this ordinance is declared invalid, such invalidity shall not affect the other parts of this ordinance.

SECTION 3. This ordinance shall take effect upon its approval.


