## ORDINANCE NO. 665

AN ORDINANCE AMENDING SECTION 7.22 (THE PAHOA ZONE MAP), ARTICLE 2, CHAPTER 8 (ZONING CODE) OF THE HAWAII COUNTY CODE, AS AMENDED, BY CHANGING THE DISTRICT CLASSIFICATION FROM SINGLE FAMILY RESIDENTIAL (RS-15) TO VILLAGE COMMERCIAL (CV-10) AT WAIAKAHIULA, PUNA, HAWAII, COVERED BY TAX MAP KEY 1-5-13:25.

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

SECTION 1. Section 7.22, Article 2, Chapter 8, (Zoning Code), of the Hawaii County Code, as amended, is further amended to add a new subsection, to read as follows:

"7.22 ( h ). The district classification of the following area situated at Waiakahiula, Puna, Hawaii, shall be Village Commercial (CV-10):

Beginning at a spike driven in Eucalyptus Tree at the north corner of this lot and on the south side of land reserved for the widening of Government Main Road, the coordinates of said point of beginning referred to Government Survey Triangulation Station "PAHOA" being 2440.67 feet South and 2620.57 feet East, and running by azimuths measured clockwise from True South:

1.	303°	15'		119.40	feet along the south side of land reserved for the widening of Government Main Road to a pipe;
2.	51°	22'		251.00	feet along Lot 22 to a pipe;
3.	133°	20'		85.80	feet along Lot 31 to a pipe;
4.	222°	05'		74.55	feet along Lot 19 to a spike;
5.	200°	02'		47.20	feet along Lot 19 to a spike;
6.	235°	28'	30"	112.26	feet along Lot 20 to the point of beginning and containing an area of 25,852 Square Feet.

All as outlined in red on the map attached hereto, marked Exhibit "A" and by reference made a part hereof.

This subsection is conditioned upon the following: (A) that the petitioner or his authorized representative submit plans for the proposed commercial facility and receive Final Plan Approval within one (1) year from the effective date of the change of zone; (B) that construction commence within one (1) year from the date of receipt of Final Plan Approval and be completed within two (2) years thereafter; (C) that the method of sewage disposal shall meet with the approval of the appropriate State and County agencies; (D) that the location of the driveway access shall meet with the approval of the Department of Public Works; and (E) that all other applicable rules, regulations and requirements, including water, shall be complied with. Should any of the foregoing conditions not be met, rezoning of the area to its original or more appropriate designation may be initiated." SECTION 2. In the event that any portion of this ordinance is declared invalid, such invalidity shall not affect the other

SECTION 3. This ordinance shall take effect upon its approval.

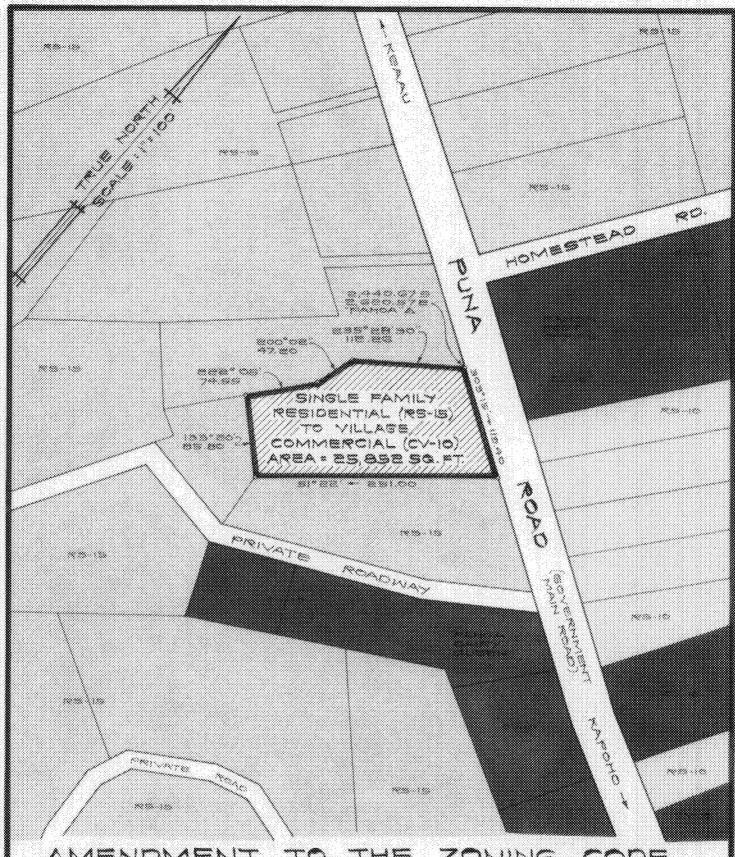
