## 

AN ORDINANCE AMENDING SECTION 7.29 (THE CITY OF HILO ZONE MAP), ARTICLE 2, CHAPTER 8 (ZONING CODE) OF THE HAWAII COUNTY CODE, AS AMENDED, TO CONFORM WITH THE COUNTY OF HAWAII GENERAL PLAN, AS AMENDED ON JULY 5, 1979, BY CHANGING THE DISTRICT CLASSIFICATION FROM RESORT-HOTEL-SAFETY (V-S-.75) TO AGRICULTURAL (A-5a) AT HONOHONONUI, SOUTH HILO, HAWAII.

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

SECTION 1. Section 7.29, Article 2, Chapter 8 (Zoning Code) of the Hawaii County Code, as amended, is further amended to add a new subsection, to read as follows:

"7.29 (tttt). The district classification of the approximately 1.7 acres of land situated at Honohononui, South Hilo, Hawaii, covered by Tax Map Key: 2-1-13:portion of 146 and 2-1-15:portion of 3, 4, portion of 6 & portion of 7 shall be Agricultural (A-5a).

The area is further described as being on the south side of Kalanianaole Avenue, between Keokea Loop on the west and the Waiahole Fish Pond on the east.

All as shown on the map marked Exhibit "A" and by reference made a part hereof."

SECTION 2. In the event that any portion of this ordinance is declared invalid, such invalidity shall not affect the other parts of this ordinance.

SECTION 3. This ordinance shall take effect upon its approval.




