ORDINANCE NO. 783

AN ORDINANCE AMENDING SECTION 7.29 (THE CITY OF HILO ZONE MAP), ARTICLE 2, CHAPTER 8 (ZONING CODE) OF THE HAWAII COUNTY CODE, AS AMENDED, TO CONFORM WITH THE COUNTY OF HAWAII GENERAL PLAN, AS AMENDED ON JULY 5, 1979, BY CHANGING THE DISTRICT CLASSIFICATION FROM RESORT-HOTEL-SAFETY (V-S-.75) TO SINGLE FAMILY RESIDENTIAL-SAFETY (RS-S-10) AT WAIAKEA, SOUTH HILO, HAWAII.

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

SECTION 1. Section 7.29, Article 2, Chapter 8 (Zoning Code) of the Hawaii County Code, as amended, is further amended to add a new subsection, to read as follows:

"7.29 (yyyy). The district classification of the approximately 35,527 square feet of land situated at Waiakea, South Hilo, Hawaii, covered by Tax Map Key: 2-1-18:27, 28 & 35 shall be Single Family Residential—Safety (RS-S-10).

The area is further described as being along the north side (makai) of Kalanianaole Avenue between the northerly extension of Kolea Street on the west and the northerly extension of Koloa Street on the east.

All as shown on the map marked Exhibit "A" and by reference made a part hereof."

SECTION 2. In the event that any portion of this ordinance is declared invalid, such invalidity shall not affect the other parts of this ordinance.

SECTION 3. This ordinance shall take effect upon its approval.


