AN ORDINANCE AMENDING SECTION 25-87 (NORTH KONA ZONE MAP) AND SECTION 25-90 (KAILUA-HONALO URBAN ZONE MAP), ARTICLE 3, CHAPTER 25 (ZONING CODE) OF THE HAWAII COUNTY CODE, BY CHANGING THE DISTRICT CLASSIFICATION FROM SINGLE FAMILY RESIDENTIAL (RS-15) TO UNPLANNED (U) AND OPEN (O); MULTIPLE FAMILY RESIDENTIAL (RM-3) TO OPEN (O); MULTIPLE FAMILY RESIDENTIAL (RM-3.5) TO UNPLANNED (U); MULTIPLE FAMILY RESIDENTIAL (RM-5.5) TO OPEN (O); UNPLANNED (U) TO MULTIPLE FAMILY RESIDENTIAL (RM-3.5) AND OPEN (O) AND FROM OPEN (O) TO UNPLANNED (U) AT KAHALUU, KEAUHOU 1 AND KEAUHOU 2, NORTH KONA, HAWAII, COVERED BY TAX MAP KEY 7-8-10:PORTION OF 30, 50, 51, 77, 79, 82, 84 and 7-8-21:PORTION OF 87.

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

SECTION 3. In the event that any portion of this ordinance is declared invalid, such invalidity shall not affect other parts of this ordinance.
