## ORDINANCE NO. 94 62

AN ORDINANCE AMENDING SECTION 25-114 (CITY OF HILO ZONE MAP), ARTICLE 3, CHAPTER 25 (ZONING CODE) OF THE HAWAII COUNTY CODE, BY DELETING A PORTION OF THE PROPOSED KUKUAU RIGHT-OF-WAY COLLECTOR STREET BETWEEN KAPIOLANI AND KUKUAU STREETS, KUKUAU 1ST, SOUTH HILO, HAWAII, COVERED BY TAX MAP KEY 2-4-25:132.

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

SECTION 1. Section 25-114, Article 3, Chapter 25 (Zoning Code) of the Hawaii County Code, is amended by deleting from the City of Hilo circulation pattern, the proposed 60-foot wide right-of-way collector street (Kukuau Street) between Kapiolani and Kukuau Streets (670  $\pm$  lineal feet).

All as shown on the map attached hereto, marked Exhibit "A" and by reference made a part hereof.

SECTION 2. In the event that any portion of this ordinance is declared invalid, such invalidity shall not affect the other parts of this ordinance.

SECTION 3. This ordinance shall take effect upon its approval.


