ORDINANCE NO. 98 99

AN ORDINANCE AMENDING SECTION 25-8-33 (CITY OF HILO ZONE MAP), ARTICLE 8, CHAPTER 25 (ZONING CODE) OF THE HAWAII COUNTY CODE, BY DELETING FROM THE CITY OF HILO CIRCULATION PATTERN, THE PROPOSED 80-FOOT WIDE RIGHT-OF-WAY NORTHERN KOMOHANA STREET EXTENSION, PIIHONUA AND PUUEO, SOUTH HILO, HAWAII, COVERED BY TAX MAP KEY 2-3-26:PORTIONS OF 2, 13, 18, 19, 25, 34, 41, 43, 44, 45, 48, 49 AND 50; AND 2-6-8:PORTIONS OF 35 AND 37.

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

SECTION 1. Section 25-8-33, Article 8, Chapter 25 (Zoning Code) of the Hawaii County Code, is amended by deleting the proposed northern Komohana Street extension right-of-way, the proposed 80-foot wide secondary arterial, from the intersection of Komohana Street and Waianuenue Avenue and onto lands on the Hamakua side of Wailuku River (approximately 1,900 lineal feet).

All as shown on the map attached hereto, marked Exhibit "A" and by reference made a part hereof.

SECTION 2. In the event that any portion of this ordinance is declared invalid, such invalidity shall not affect the other parts of this ordinance.

SECTION 3. This ordinance shall take effect upon its approval.

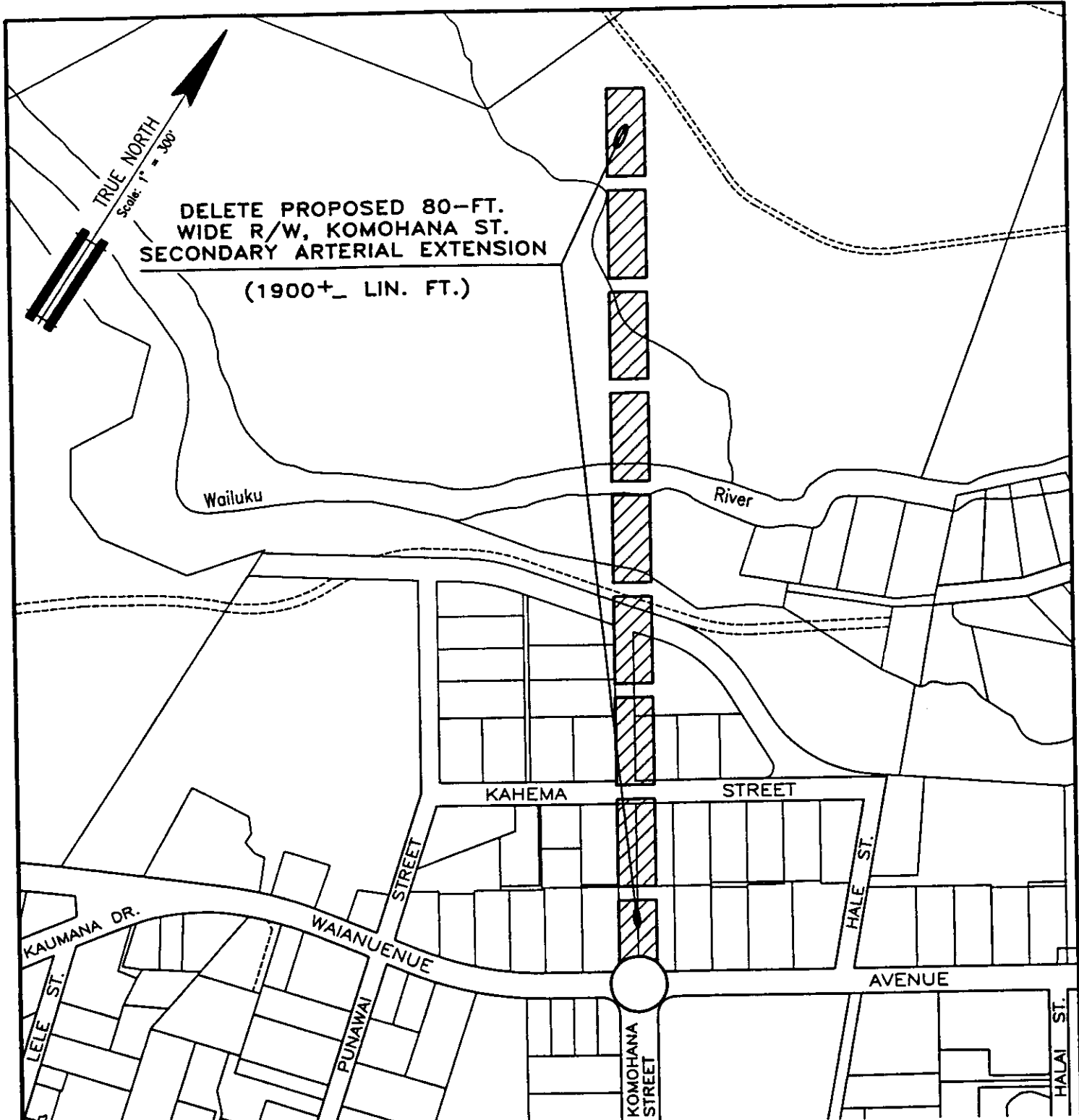
