ORDINANCE NO. 17 16

AN ORDINANCE AMENDING SECTION 25-8-15 (HĀMĀKUA DISTRICT MAP), ARTICLE 8, CHAPTER 25 (ZONING CODE) OF THE HAWAI'I COUNTY CODE 1983 (2016 EDITION, AS AMENDED), BY CHANGING THE DISTRICT CLASSIFICATION FROM RESORT-HOTEL – 25,000 SQUARE FEET (V-25) AND AGRICULTURAL – FORTY ACRES (A-40a) TO SINGLE FAMILY RESIDENTIAL – TEN ACRES (RS-10a) AND SINGLE FAMILY RESIDENTIAL - FIVE ACRES (RS-5a) AT KUKUIHAELE, WAIKOEKOE, HĀMĀKUA, HAWAI'I, COVERED BY TAX MAP KEY: 4-8-006:003, 4-8-006:013 AND 4-8-006:069.

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAI'I:

SECTION 1. Section 25-8-15, Article 8, Chapter 25 (Zoning Code) of the Hawai'i County Code 1983 (2016 Edition, as amended), is amended to change the district classification of property described hereinafter as follows:

The district classification of the following area situated at Kukuihaele, Waikoekoe, Hāmākua, Hawai'i, shall be Single Family Residential – 10 acres (RS-10a) and Single Family Residential – 5 acres (RS-5a):

LOT A

Beginning at the northeast corner of this parcel of land, and on the south side of Government Main Road, the coordinates of said point of beginning referred to Government Survey Triangulation Station "PUU MAUU NORTH" being 7,272.23 feet North and 2,323.29 feet East and running by azimuths measured clockwise from True South:

SECTION 3. In the event that any portion of this ordinance is declared invalid, such invalidity shall not affect the other parts of this ordinance.


SECTION 4. This ordinance shall take effect upon its approval.
