ORDINANCE NO. 00 13

AN ORDINANCE AMENDING THE STATE LAND USE BOUNDARIES MAP, H-25 FOR THE COUNTY OF HAWAII, BY CHANGING THE DISTRICT CLASSIFICATION FROM THE AGRICULTURAL TO THE RURAL DISTRICT AT OULI, SOUTH KOHALA, HAWAII, COVERED BY TAX MAP KEY 6-2-11:11.

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII:

SECTION 1. The State Land Use Boundaries Map, H-25 for the County of Hawaii, is amended to change the district classification of property described hereinafter as follows:

The district classification of the following area situated at Ouli, South Kohala, Hawaii, shall be Rural:

Beginning at the southwest corner of this parcel of land, being the southeast corner of Lot 10 and on the northerly side of Road Lot "B", the coordinates of said point of beginning referred to Government Survey Triangulation Station "PUU PA" being 11,323.25 feet north and 14,342.86 feet west, thence running by azimuths measured clockwise from true south:

- 1. 166° 21' 27" 944.51 feet along Lot 10;
- 2. Thence along Kawaihae-Waimea Road (F.A.P. NRH 11-C), along a curve to the right with a radius of 686.30 feet, the chord azimuth and distance being:


