AN ORDINANCE AMENDING THE STATE LAND USE BOUNDARIES MAP, H-66 FOR THE COUNTY OF HAWAII, BY CHANGING THE DISTRICT CLASSIFICATION FROM THE AGRICULTURAL TO THE URBAN DISTRICT AT WAIAKEA, SOUTH HILO, HAWAII, COVERED BY TAX MAP KEY 2-4-35 25

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII

SECTION 1 The State Land Use Boundaries Map, H-66 for the County of Hawaii, is amended to change the district classification of property described hereinafter as follows

The district classification of the following area situated at Waiakea, South Hilo, Hawaii, shall be Urban

LAND SITUATED AT WAIAKEA, SOUTH HILO, ISLAND OF HAWAII, HAWAII

Being a portion of Grant 10,594 to Oteru Takehiro Koshiyama, being also a portion of Lot B, Waiakea Homesteads, 2nd Series

Beginning at the northeast corner of this parcel of land, being also the northwest corner of Lot B-2 and on the south side of Roadway Lot A, the coordinates of said point of beginning referred to Government Survey Triangulation Station "HALAI", being 17,549 61 feet South and 3,574 62 feet West, thence running by azimuths measured clockwise from true South


