ORDINANCE NO. 01 12

AN ORDINANCE AMENDING THE STATE LAND USE BOUNDARIES MAP, H-13 FOR THE COUNTY OF HAWAII, BY CHANGING THE DISTRICT CLASSIFICATION FROM THE AGRICULTURAL TO THE URBAN DISTRICT AT PUEHUEHU, NORTH KOHALA, HAWAII, COVERED BY TAX MAP KEY 5-4-2.PORTION OF 6

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII.

SECTION 1. The State Land Use Boundaries Map, H-13 for the County of Hawaii, is amended to change the district classification of property described hereinafter as follows:

The district classification of the following area situated at Puehuehu, North Kohala, Hawaii, shall be Urban:

Beginning at the Northeast corner of this parcel of land, situated on the Southwesterly side of Hawi-Niulii Road, being also the Northwest corner of Lot 1 of Kynnersley Road Tract 1, Block "A" (FILE PLAN 651), the coordinates of said point of beginning, referred to Government Survey Triangulation Station "PUU O NALE" being 12,726 18 feet North and 9,527 31 feet East and thence running by azimuths measured clockwise from True South


