## ORDINANCE NO. 01 14

AN ORDINANCE AMENDING THE STATE LAND USE BOUNDARIES MAP, H-8 FOR THE COUNTY OF HAWAII, BY CHANGING THE DISTRICT CLASSIFICATION FROM THE AGRICULTURAL TO THE URBAN DISTRICT AT KEAUHOU 1<sup>ST</sup>, NORTH KONA, HAWAII, COVERED BY TAX MAP KEY 7-8-11·9

## BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAII

SECTION 1 The State Land Use Boundaries Map, H-8 for the County of Hawaii, is amended to change the district classification of property described hereinafter as follows:

The district classification of the following area situated at Keauhou 1st, North Kona, Hawaii, shall be Urban

Beginning at a ½ inch pipe at the Southwesterly corner of this parcel of land, being also the Northwesterly corner of Lot 1-A and being a point on the Easterly boundary of Lot 5-A, the coordinates of said point of beginning referred to Government Survey Triangulation Station "KEAUHOU COAST" being 4,465.69 feet North and 3,706 82 feet East and running by azimuths measured clockwise from True South


