### ORDINANCE NO. 04 85

AN ORDINANCE AMENDING THE STATE LAND USE BOUNDARIES MAP, H-14 FOR THE COUNTY OF HAWAI'I, BY CHANGING THE DISTRICT CLASSIFICATION FROM THE AGRICULTURAL TO THE RURAL DISTRICT AT OULI, SOUTH KOHALA, HAWAI'I, COVERED BY TAX MAP KEY 6-2-11:10.

#### BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAI'I:

SECTION 1. The State Land Use Boundaries Map, H-14 for the County of Hawai'i, is amended to change the district classification of property described hereinafter as follows:

The district classification of the following area situated at Ouli, South Kohala, Hawai'i, shall be Rural:

Beginning at the Southeasterly corner of this parcel of land, being also the Southwesterly corner of Lot 11-B of Anekona Estates and being a point on the Northerly side of Road Lot "B", the coordinates of said point of beginning referred to Government Survey Triangulation Station "PUU PA" being 11,323.25 feet North and 14,342.86 feet West and running by azimuths measured clockwise from True South:

1.	73°	42'		280.00	feet along the Northerly side of Road Lot "B" to a point;
2.	163°	42'		743.06	feet along Lot 9 of Anekona Estates and along the remainder of Royal Patent 2237, Land Commission Award 8518-B, Apana 1 to James Young Kanehoa to a point;
3.	220°	16'	10"	257.64	feet along the Southerly side of Kawaihae-Waimea Road (F.A.P. NRH 11-G) to a point;

Thence, following along the Southerly side of Kawaihae-Waimea Road (F.A.P.

NRH 11-G) on a curve to the right with a radius of 686.30 feet, the chord azimuth and distance being:

4.	225°	25'	55"	123.51	feet to a point;

5. 346° 21' 27" 944.51 feet along Lots 11-A and 11-B of Anekona Estates to the point of beginning and containing an area of 5.832 Acres.

SECTION 2. In the event that any portion of this ordinance is declared invalid, such invalidity shall not affect the other parts of this ordinance.

SECTION 3. This ordinance shall take effect upon its approval.


