AN ORDINANCE AMENDING THE STATE LAND USE BOUNDARIES MAPS FOR THE COUNTY OF HAWAI'I BY CHANGING THE DISTRICT CLASSIFICATION FROM THE AGRICULTURAL TO THE URBAN DISTRICT AT KAHULUI 2ND, NORTH KONA, HAWAI'I, COVERED BY TAX MAP KEY: 7-5-017:042.

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAI'I:

SECTION 1. The State Land Use Boundaries Maps for the County of Hawai'i are

amended to change the district classification of property described hereinafter as follows:

The district classification of the following area situated at Kahului 2nd, North

Kona, Hawai'i, shall be Urban:


