Per our discussion, I have enclosed four (4) copies of the Draft Villages at Hokukano Public Access and Shoreline Management Plan (Plan) for review by your Department and other relevant County agencies. The Plan, which represents a cooperative effort on the part of Oceanside 1250 and its Community Advisory Group (CAG), is intended to address the requirements of Ordinances 96-7 and 96-8 and SMA Use Permit No.345 pertaining to the preparation of a comprehensive public access plan and the phasing of park improvements.
