## LIBER 362, Pages 263-265

This is a partition deed, made this 1st day of February, A. D. 1911 between ILIANU IULA (K), MRS. IKANAKA KUILIPULE (W), MRS. MIKOLIANA JOE MANUNU (W), KAMALU, own children of Marie, (w), deceased, sister of D. W. Kuilipule, deceased, and KAAIE (K), husband of said Marie, deceased, of South Kona, County of Hawaii, parties of the First Part, and L. KAUWAHI (K) of the same place, the party of the Second Part.

This partition deed witnesseth as follows:

The parties of the First Part, and the party of the Second Part make known that they have interest severally and jointly, in the land of D. W. Kuilipule, deceased intestate, situate at Alika, South Kona, Hawaii, containing an area of 788 acres; as the same is shown in the Partition Deed made on the 25th day of February, A. D. 1898, between Kawaauhau (k), Kaai Kalalauwale (w), Marie Kiaimoku (w) and Mikoliana Fong Kui (w) and D. W. Kuilipule aforesaid, which instrument is recorded in Liber 183 pages 98 & 99.

By virtue of the agreement by the parties of the First and Second Parts aforesaid, to partition the said 788 acres of land of D. W. Kuilipule, deceased intestate among the true heirs in accordance with law and equity, as the same is more fully set forth in this partition deed.

Whereas the share of the party of the second part in the land of D. W. Kuilipule mentioned above comprises 72.25 acres, more or less.

Wherefore, by virtue of the agreement between the Parties of the First and Second Parts and in consideration of the sum of One Dollar (\$1.00) to each of us the said Parties of the First Part,

paid by the Party of Second Part, L. KAUWAHI, the receipt whereof is hereby acknowledged.

Therefore, know all men to whom this partition deed shall come, each of the said Parties of the First Part do hereby sell, give, release and convey absolutely, each of our interest in the parcel and land share, containing an area of 72.25 acres the boundaries of which are shown by survey hereinafter set forth as follows:

Beginning at the Northwest corner of this share at seashore and running inland

North 77° 30' East 12,800 feet adjoining Ikanaka's land division, crossing government road to the boundary mauka of this land; thence turn and running

South 25° 00' East 250 feet to the Northeast corner of Mrs. Mikoliana's land division, thence turn and running toward the sea

South 77° 30' West 12,865 feet adjoining Mrs. Mikoliana's land division to seashore, thence running along seashore to the place where survey began, 245 feet.

The foregoing land division contains 72.25 acres, more or less. The parcel of land, the area and boundaries of which are shown above, together with all rights and benefits of every nature and kind, appurtenant thereto and situate thereon, belongs absolutely to L. KAUWAHI, of the Second Part, and to his heirs and assigns forever.

wife of Ilianu Iula, the persons hereinbefore mentioned, for the reasons agreed to by the parties of the First Part and for the sum of One Dollar (\$1.00) to each of us paid by L. Kauwahi of the Second Part, the receipt whereof is hereby acknowledged do hereby sell, give, release and convey absolutely all of our interests at law and in equity in the parcel of land the area of which is hereinbefore described, together with all rights and benefits appurtenant thereto and situate thereon to belong absolutely to L. KAUWAHI aforesaid and to his heirs and assigns forever.
