This is in response to your letter we received on May 16, 2008, requesting the naming of a roadway within Opihihale Sunset View Estates. You propose:

We have determined that your proposed street name is acceptable and available. **Ahe Kolo Place** has been reserved for naming the above referenced roadway.

Our records show that the roadway in this subdivision is a private roadway. You will be responsible to install a street sign to identify this roadway. See attached items for guidance on the placement of your sign. If additional information is needed, please consult the Department of Public Works, Traffic Division at 961-8341.

For your information, the United States Postal Service (USPS) has informed this office of new mail delivery guidelines, which encourages the use of centralized mail delivery equipment.
