Dear Sirs:

I am writing this letter with good intention and much reserve. It would be far easier for me to ignore the disrespectful treatment of the existing ancestral native Hawaiian unmarked burials than to expose this on a property that I own.

It would be far easier to turn my head and look the other way at the destruction and desecration of the culturally significant archaeology and let "someone else" deal with it in the future, but that is what the past owners, their representatives, and the authorities have done and I know that is wrong.

I am writing this letter to all the parties involved, including the owners, previous owners, their representatives and consultants, and the State and County governmental authorities because ALL of us have a responsibility and duty to the others and the public in taking action in preserving,

restoring and maintaining these historically and culturally significant properties and doing the right thing.

If you are receiving this it is because you have been chosen and after reading it you will make a choice also. You can choose to ignore it and hope someone else deals with it or you can proactively contact the other parties and collectively come up with a solution that is in the best interest of as many of the parties as possible. If you received this in error and have nothing to do with you I apologize, you can ignore it or pass it on as you see fit.

Additionally since I am currently involved in multiple lawsuits regarding this property and the archaeology thereon, some of you listed and some of the people who will be adversely affected by my coming forward and exposing this will claim that my coming forward has something to do with the lawsuits. This is untrue since the outcome of the lawsuits and my damages are not dependent on whether or not the archeology is ever restored or preserved. In fact if you and everyone else ignore it, it is an open invitation to the current and future owners to continue "business as usual in South Kona".

The activity started on or about 1996 on TMK 3-8-7-13:6 and is continuing on the surrounding properties in the original Create 21 Chuo subdivision also known as Opihihale Sunset View Estates in South Kona on the Big Island of Hawaii. The original subdivision commenced construction, was granted a grading permit, and later was granted Final Hawaii County Subdivision Approval in 2000 WITHOUT the developer ever submitting a final preservation and mitigation plan and WITHOUT the developer in any way preserving any of the 8 sites slated for preservation or performing the remaining data recovery on the 16 existing other sites. Since that time 4 homes have been built on, around and over many of these sites. It is believed that the Heiau may still be intact, much of the trail will still be there, and that the burials have been dozed over.

In 2004 this same property applied for a Planned Unit Development (PUD 2005-000002) representing the archeology survey on the above property as what was required for the lower 168+ acres. This PUD was approved in 2005 based on this erroneous archeology survey.

I have attached a declaration that I made in the legal proceedings that are ongoing. This explains most of what has happened. I have attached other information that should help you in your investigations. I am available to assist you in any way to get you any and all information that I personally have or have access to.

Thank you in advance, I know you will do what you know is right in your hearts.
