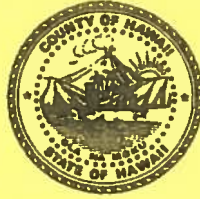

**Subject: Street Name Change in South Kona**  
**Keeki Beach Road to Keawaiki Road**

This is in response to your request for the County's recognition regarding a certain roadway in the South Kona District.

You requested that we recognize the roadway presently known as Keeki Beach Road as an extension of Keawaiki Road, thus, replacing the roadway name from Keeki Beach Road to Keawaiki Road. We are in agreement with the road alignment and street name change. We will notify the appropriate agencies of these changes. Please be aware that street addresses for property owners along this roadway will change to reflect the new street name.

Our records show that the roadway is a private roadway. You will be responsible to install a street sign to identify this roadway. See attached items for guidance on the placement of your sign. If additional information is needed, please consult the Department of Public Works, Traffic Division at 961-8341.

For your information, the United States Postal Service (USPS) has informed this office of new mail delivery guidelines, which encourages the use of centralized mail delivery equipment. We have enclosed a flyer provided by the USPS. If you and other landowners situated along these newly named roadways are contemplating mail delivery, we encourage you to contact the local USPS Growth Coordinator at (808) 423-3908.
