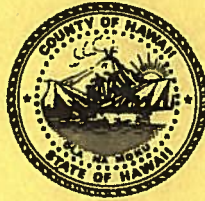

TMK: 8-3-5:Por. of 1 and-8-3-4:Por. of 1, South Kona, Hawai'i**

This is to acknowledge receipt of your May 1, 2013 email regarding compliance with the conditions of approval of SMM 13-000259.

SMM 13-000259 was approved on February 6, 2013. Those conditions with time frames and their current status are as follows:

- 3. A Conservation District Use Permit from the Board of Land and Natural Resources or other written approval from the Department of Land and Natural Resources, Office of Conservation and Coastal Lands must be obtained for the project within one (1) year from the date of approval of this permit.**

Conservation District Use (CDUP) HA-3647 for the waterline improvements was approved on March 4, 2013. As the CDUP was obtained before February 6, 2014, this condition has been complied with.

- 4. The applicant shall secure a "plumbing only" Plumbing Permit within one (1) year from the date of approval of this permit.**

The Plumbing Permit must be obtained by February 6, 2014.

- 5. The applicant shall submit a copy of SHPD's approval of the revised Archaeological Inventory Survey prior to commencement of any land alteration or construction activities.**

By letter dated February 20, 2013, the Revised Archaeological Inventory Survey was accepted by SHPD. By letter dated April 3, 2013, the required archaeological monitoring plan (AMP) was also accepted by SHPD. Therefore, this condition has been complied with.

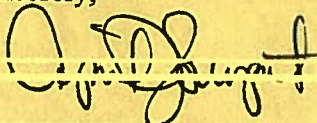
